

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to replied.app and REPLIED.APP LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to REPLIED.APP LLC include replied.app. The REPLIED.APP LLC website is a Wedding planning app site.
